WHEREAS, there have been a video circulating through Social Media that a citizen has been allegedly denied a treatment by Taytay Emergency Hospital within the jurisdiction of Taytay dated April 24, 2020;


WHEREAS, such Public Hospitals and its Administrative Staffs and all persons directly responsible for the failure to provide adequate treatment needs to be investigated and eventually be held responsible as determined by the proper court;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby REQUESTS THE LOCAL CHIEF EXECUTIVE, HON. GEORGE RICARDO R. GACULA II TO CALL FOR AN INVESTIGATION OF THE INCIDENT THAT HAPPEN AT THE TAYTAY EMERGENCY HOSPITAL LAST APRIL 24, 2020 OF THE LATE JOSIE MABINI AND TO PREVENT ITS RECURRENCE.

RESOLVED FURTHER, that Executive Department shall furnish the Sangguniang Bayan a copy of the Investigation Report including the Medical Records of the patient on the next Regular Session.
