A RESOLUTION ENJOINING THE FIVE SANGGUNIANG BARANGAYS IN TAYTAY AND THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE-TAYTAY TO POST THE LIST OF RECIPIENTS OF THE SOCIAL AMELIORATION PROGRAM FROM THEIR RESPECTIVE BARANGAYS ON THEIR OFFICIAL SOCIAL MEDIA ACCOUNTS

WHEREAS, the Social Amelioration Program have been operational in Taytay, Rizal with 33,079 households as target beneficiaries have received P6,500.00 cash subsidies from the Department of Social Welfare and Development;

WHEREAS, DILG Secretary Eduardo M. Ano has directed Punong Barangays to post the list of recipients in conspicuous places within their Barangays to ensure transparency in the identification of the recipients and promote honest and orderly management of the SAP funds,

WHEREAS, not all can have the means to go to the barangay hall and to deter the people from going to check the list, it is timely and practical to post the list of recipients of each barangay on their official social media accounts as means to of other option for posting;

WHEREAS, most of the inhabitants can access the said list in the name of transparency and to help avoid inciting violation of the ECQ Guidelines such as physical distancing;


