**RESOLUTION NO. 203 series of 2020**

**A RESOLUTION MANDATING THE STRICT IMPLEMENTATION OF THE GUIDELINES TO FOLLOW ON MINIMUM HEALTH PROTOCOLS FOR BARBERSHOP AND SALON AS ISSUED BY THE DEPARTMENT OF TRADE AND INDUSTRY (DTI) IN THE MUNICIPALITY OF TAYTAY**

WHEREAS, on May 29, 2020 the Inter-Agency Task Force (IATF) for the management of emerging infectious disease had issued Resolution 41, series of 2020 part of which the recommendation approved in the resolution states that:

xxxx...(B) The recommendation of the Department of Trade and Industry (DTI) to reclassify the barbershop and salon industry as Category III is hereby approved, the proposed protocols for their reopening are hereby adopted...xxxx;

xxxx...(2) The recommendation to gradually reopen salon and barbershop is hereby approved, the details of which are as follows: (a) In areas under general community

quarantine, the industry can begin to reopen on 7 June 2020 at thirty percent (30%) operational capacity. The operational capacity of salon and barbershop can gradually increase to 50% provided that venue capacity allows for social distancing protocols. The gradual increase shall be scheduled every two weeks from the effectivity of this Resolution subject to regular assessment of the IATF. Provided further that such businesses are compliant with the proper protocols as prescribed by the DTI... xxxx;

xxxx... (3) The resumption of, and continued operations of salons and barbershops shall be subject to their proprietors' compliance with the proper health protocols set by the DTI. Further, their compliance shall be assessed through a post-audit mechanism which shall be led by the DTI, DOH, LGU Health Office and/or other deputized organizations... xxxx;

WHEREAS, the Municipal Government of Taytay had been constantly working as partner with the National Government in easing the effect of Pandemic to the constituents and the business community as well, without sacrificing the health and living condition, as a top priority;

WHEREAS, the inclusion of Barbershop and Salon Industry as part of the allowed operational businesses to operate from June 7, 2020 onward will violate social distancing protocol without setting clear guidelines agreement to follow;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby MANDATES THE STRICT IMPLEMENTATION OF THE GUIDELINES TO FOLLOW ON MINIMUM HEALTH PROTOCOLS FOR BARBERSHOP AND SALON AS ISSUED BY THE DEPARTMENT OF TRADE AND INDUSTRY (DTI) IN THE MUNICIPALITY OF TAYTAY.


