RESOLUTION APPROPRIATING THE AMOUNT OF ONE HUNDRED
THIRTY-FIVE MILLION FIVE HUNDRED SIX THOUSAND FOUR HUNDRED
SEVENTY-SEVEN PESOS (PHP 135,506,477.00) REPRESENTING THE 20%

WHEREAS, Section 16 of the Local Government Code, states that every LGU shall appropriate in its annual budget no less than twenty percent (20%) of its Annual Internal Revenue Allotment for development projects;

WHEREAS, submitted to the Honorable August Body is Municipal Development Council (MDC) Resolution No. 2020 - 011 appropriating the amount of One Hundred Thirty-Five Million

Five Hundred Six Thousand Four Hundred Seventy-Seven Pesos (Php 135,506,477.00), the amount equivalent to the 20% of Annual Internal Revenue Allotment of this Municipality, for approval and ratification;

WHEREAS, integrated in MDC Resolution No. 2020 - 011 are priority development projects and programs to be funded out of the 20% Development Fund for FY 2021;

WHEREAS, projects and programs to be funded out of the 20% Development Fund are truly responsive to the needs of the community and supportive of the Development goals and thrusts of the Municipality;




