A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II OF TAYTAY, RIZAL TO NEGOTIATE AND ENTER INTO AGREEMENT OR CONTRACT WITH ANY ENTITY FOR A PARCEL OF LAND TO BE USE EXCLUSIVELY FOR BUREAU OF FIRE PROTECTION (BFP) BLDG. AND PHILIPPINE NATIONAL POLICE (PNP) BLDG.

WHEREAS, Taytay, Rizal had now become one of the most populous municipality in our country today;

WHEREAS, our Municipality had now more or less 400,000 inhabitants and more than 80,000 households;

WHEREAS, peace and order had become one of our major concern due to our dense population;

WHEREAS, there is a need to have a bigger and improved BFP and PNP facilities;

WHEREAS, the BFP and PNP had a support program to provides for the constructions of the buildings, provided that the Local Government Unit (LGU) shall provide the lots wherein the buildings will be established;

WHEREAS, Sect. 16 of RA. 7160, Local Government Code of the Philippines provides for the promotion of the general welfare of our constituents;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal duly assembled in session hereby authorize a resolution entitled, A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II OF TAYTAY, RIZAL TO NEGOTIATE AND ENTER INTO AN AGREEMENT OR CONTRACT WITH ANY ENTITY FOR A PARCEL OF LAND TO BE USE EXCLUSIVELY FOR BUREAU OF FIRE PROTECTION (BFP) BLDG. AND PHILIPPINE NATIONAL POLICE (PNP) BLDG.
