A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH PHILIPPINE STATISTICS AUTHORITY (PSA) FOR THE IMPLEMENTATION OF THE NATIONAL ID SYSTEM

WHEREAS, Republic Act No. 11055 (R.A. 11055) created the Philippine Identification System or "PhilSys" for the establishment of a single national Identification system to register all Filipinos and resident aliens of the Republic of the Philippines;

WHEREAS, Section 15 of the Implementing Rules and Regulations (IRR) of R.A. 11055 vested PSA the primary implementation of PhilSys and empowered it to collaborate with Local Government Units (LGUs), other government agencies, and Government Owned or Controlled

Corporations (GOCCs) to ensure the registration and enrollment of all citizens and resident aliens in the PhilSys including the Indigenous Cultural Communities / Indigenous Peoples and those located in remote localities;

WHEREAS, Memorandum Circular No. 2020-99 dated July 15, 2020 of the Department of Interior and Local Government (DILG) enjoined all LGUs and Regional DILG Offices to provide assistance in the implementation of PhilSys registration operations in their respective localities;

WHEREAS, the implementation of the National ID System will greatly benefit the constituents of this municipality;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH PHILIPPINE STATISTICS AUTHORITY (PSA) FOR THE IMPLEMENTATION OF THE NATIONAL ID SYSTEM.

RESOLVED FURTHER, that the duly signed Memorandum of Agreement (MOA) shall be ratified first by the Sangguniang Bayan before its implementation.

RESOLVED FURTHERMORE, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
