RESOLUTION NO. 284 series of 2021

A RESOLUTION EARNESTLY AND RESPECTFULLY REQUESTING HONORABLE WENDELL ELIOT AVISADO, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO GRANT TWENTY MILLION PESOS (PHP 20,000,000) FOR THE RECONSTRUCTION AND IMPROVEMENT OF THE DILAPIDATED SLAUGHTERHOUSE OF THIS MUNICIPALITY

WHEREAS, Republic Act 9296, otherwise known as the Meat Inspection Code of the Philippines provides that the LGU shall endeavor to improve existing meat facilities to comply with the national standards, and the National Government shall allocate funds as incentive equivalent to the funds available from the LGU's for the purpose;

WHEREAS, the single existing public abattoir in Taytay, Rizal which is vital in the butchering of meat for continuous provision of supplies for the consumption of the general public

is currently in a tattered state because of its long-term usage and other factors such as the normal wear and tear of facilities;

WHEREAS, having a reconstructed and an up-to-date slaughterhouse with a Sewage Treatment Plant (STP) will greatly address the promotion of health and sanitation within the vicinity of the facility and will ensure that the butchering establishment will be up to National standards at all times;


WHEREAS, much to the desire of Local Government Unit of Taytay to prioritize the reconstruction and improvement of the Municipalities Slaughterhouse, it is deterred by the insufficient funds of this LGU that were allotted to more pressing needs, hence the prayer for help and assistance from the National Government for the realization of this project;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby EARNESTLY AND RESPECTFULLY REQUESTS HONORABLE WENDELL ELIOT AVISADO, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO GRANT TWENTY MILLION PESOS (PHP 20,000,000) FOR THE RECONSTRUCTION AND IMPROVEMENT OF THE DILAPIDATED SLAUGHTERHOUSE OF THIS MUNICIPALITY.
