A RESOLUTION RATIFYING THE CONTRACT OF LEASE BY AND BETWEEN THE MUNICIPALITY OF TAYTAY REPRESENTED BY THE MUNICIPAL MAYOR, HON. GEORGE RICARDO R. GACULA II AND JULIANA WET AND DRY MARKET REPRESENTED BY ITS OWNER, MR. MELQUIADES A. ROBLES, FOR THE PROPERTY LOCATED AT SAKBIT LUPANG ARENDA, BRGY. STA. ANA, TAYTAY, RIZAL

WHEREAS, the 11th Sangguniang Bayan of Taytay had adopted Resolution No. 254 series of 2020 entitled: “A Resolution authorizing the Local Chief Executive Hon. George Ricardo R. Gacula II to negotiate and enter into a Memorandum of Agreement (MOA) with Mr. Melquiades A. Robles, Proprietor of Juliana Wet and Dry Market for the lease of property located at Sakbit Lupang Arenda, Brgy. Sta. Ana, Taytay, Rizal”;

WHEREAS, the Contract of Lease for the property located at Sakbit Lupang Arenda, Brgy. Sta. Ana, Taytay, Rizal between the Municipality of Taytay and Juliana Wet and Dry Market was signed and notarized on March 10, 2021;

WHEREAS, said Contract of Lease is instrumental to the revival of the wet and dry market at Sakbit Lupang Arenda, providing livelihood opportunities to the residents of the area, and will help in decongesting the foot traffic at Taytay Public Market this time of pandemic;

GEORGE RICARDO R. GACULA II AND JULIANA WET AND DRY MARKET REPRESENTED BY ITS OWNER MR. MELQUIADES A. ROBLES FOR THE PROPERTY LOCATED AT SAKBIT LUPANG ARENDA, BRGY. STA. ANA, TAYTAY, RIZAL.
