A RESOLUTION EARNESTLY REQUESTING MS. ANDREA D. DOMINGO, CHAIRPERSON AND CEO, PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) THROUGH MS. MILAGROS PAULINE L. VISQUE, AVP-ENGINEERING DEPARTMENT, TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF AN EVACUATION CENTER WITH COMPLETE AMENITIES AT BARANGAY SAN JUAN, OF THE MUNICIPALITY OF TAYTAY

WHEREAS, R.A. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, fulfils its constitutional mandate to protect the rights of the people to life and property by capacitating the people addressing the root causes of vulnerabilities to disasters, building disaster-resilient communities and even adapting and mitigating the impacts of climate change;

WHEREAS, Section 2 (1) of RA 10121 provides that it is the policy of the State to recognize and strengthen the capacities of LGUs and communities in mitigating and preparing for, responding to, and recovering from the impact of disasters;

WHEREAS, the Local Government Unit of Taytay has capacitated its manpower and resources to mitigate the vulnerable circumstances that would occur in times of disasters or calamities, and thereby has allocated a portion at the one (1) hectare area, more or less, for the construction of an evacuation center that would cater evacuees during disaster eventualities;

WHEREAS, the above-mentioned project will be established in a strategic area and be structurally sound built to withstand and ensure the safety of local residents;


WHEREAS, the Municipal Government of Taytay through its officials is so desirous to materialize this program endeavors but has no sufficient financial resources to implement and realize such project in order to respond to any impact of calamity;
