AUTHORIZING HON. MAYOR ALLAN MARTINE S. DE LEON, HON. VICE-MAYOR SOPHIA PRISCILLA L. CABRAL, ATTY. SOLIMAN ALLEN V. BAUTISTA, MUNICIPAL ADMINISTRATOR AND MS. MELINDA V. REYES, ACTING MUNICIPAL TREASURER, TO SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF TAYTAY ALL WARRANTS DRAWN WITH THE ACCOUNT CORRESPONDING TO THE EXECUTIVE AND LEGISLATIVE DEPARTMENT MAINTAINED BY THE MUNICIPAL GOVERNMENT OF TAYTAY WITH LANDBANK OF THE PHILIPPINES-TAYTAY BRANCH AND PHILIPPINE VETERANS BANK-TAYTAY BRANCH

WHEREAS, Hon. Mayor Allan Martine S. De Leon and Hon. Vice Mayor Sophia Priscilla L. Cabral, assumed their respective offices after the last 2022 election;

WHEREAS, pursuant to Local Government Code of 1991 Section 445 (a)(1), the Municipal Mayor shall sign all warrants drawn on the municipal treasury for the expenditures appropriated for the operation of the Executive Branch and the Municipal Vice Mayor shall sign all warrants drawn on the municipal treasury for all expenditures appropriated for the operation of the Legislative Branch;

WHEREAS, the Municipal Government of Taytay maintains funds/accounts with the Landbank of the Philippines and Philippine Veterans Bank both Taytay Branch;


WHEREAS, a resolution authorizing the Municipal Mayor Allan Martine S. De Leon and the Municipal Vice-Mayor Sophia Priscilla L. Cabral, Municipal Administrator Atty. Soliman Allen V. Bautista and Acting Municipal Treasurer Ms. Melinda V. Reyes to sign for in behalf of the Municipality of Taytay all warrants drawn with the account maintained at Landbank of the Philippines-Taytay Branch and Philippine Veterans Bank-Taytay Branch is needed for the immediate implementation of programs and projects as well as the delivery of basic services and facilities to our constituents;

SOLIMAN ALLEN V. BAUTISTA AND MS. MELINDA V. REYES AND LEGISLATIVE DEPARTMENT BY VICE-MAYOR SOPHIA PRISCILLA L. CABRAL AND MS. MELINDA V. REYES, MAINTAINED BY THE MUNICIPAL GOVERNMENT OF TAYTAY WITH LANDBANK OF THE PHILIPPINES-TAYTAY BRANCH AND PHILIPPINE VETERANS BANK-TAYTAY BRANCH.
