RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE NINA RICCI A. YNARES, RIZAL PROVINCIAL GOVERNOR, FOR THE CONSTRUCTION OF A 4-STOREY MULTI-PURPOSE BUILDING AT KALAYAAN PARK, BARANGAY SAN JUAN, TAYTAY, RIZAL

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, states that “Every local government unit shall exercise the powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, including the construction of infrastructure facilities intended primarily to service the needs of the residents of the municipality”;

WHEREAS, the Local Chief Executive, Hon. Allan Martine S. De Leon, have expressed its aspiration to bring the government closer to its constituents by having a multi-purpose building built / constructed in the vicinity of Kalayaan Park, Brgy. San Juan, Taytay, Rizal;

WHEREAS, consistent with the executive agenda, the 12th Sangguniang Bayan of Taytay, Province of Rizal, desirous of an effective, efficient and equitable administrative governance, fully supports the construction of a multi-purpose building at Kalayaan Park, Brgy. San Juan, Taytay, Rizal;

WHEREAS, the proposed area for the requested 4-storey Multi-Purpose Building is situated at the back of the stage of Kalayaan Park.

WHEREAS, the Local Government Unit lacks the resources to construct a Multi-Purpose Building and humbly requests the Provincial Government for this endeavor of bringing the government closer to the people;

WHEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby RESPECTFULLY REQUESTS THE HONORABLE NINA RICCI A. YNARES, RIZAL PROVINCIAL GOVERNOR, FOR THE CONSTRUCTION OF A 4-STOREY MULTI-PURPOSE BUILDING AT KALAYAAN PARK, BARANGAY SAN JUAN, TAYTAY, RIZAL.

RESOLVED FURTHER, that copies of this Resolution be forwarded to all concerned for their information and appropriate action.


