WHEREAS, Chapter II, Section 17 (3)(v) of Republic Act No. 7160, otherwise known as the Local Government Code, states the Provincial Government shall provide Basic Services and Facilities which includes “[s]ocial welfare services which include programs and projects on rebel returnees and evacuees; relief operations; and population development services”;

WHEREAS, Apollo Street, Barangay San Isidro, Taytay, Rizal (from Victoria Street Cainta to Amihan Bridge, Sta. Ana, Taytay, Rizal), currently suffers from extreme flooding due to old and undeveloped canal and low elevation of the road brought about by the abrupt increment of the general elevation of nearby roads from repairs and reconstructions;

WHEREAS, the residents’ experience being the catch basin of excess flood water of Victoria Street Cainta and Maningning Creek can be addressed by the construction of road with improvement of drainage project;

WHEREAS, the construction of road with improvement of drainage at Apollo Street, Barangay San Isidro, Municipality of Taytay, Province of Rizal, is not included in the budget of the Municipal Government;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby RESPECTFULLY REQUESTS THE HONORABLE RIZAL PROVINCIAL GOVERNOR, NINA RICCI A. YNARES-CHIONGBIAN, TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF ROAD WITH IMPROVEMENT OF DRAINAGE AT APOLLO STREET, BARANGAY SAN ISIDRO, MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.

RESOLVED FURTHER, that copies of this Resolution be furnished to the Office of the Governor of Rizal and all concerned for their consideration and perusal.
