WHEREAS, the Municipal Government of Taytay, considering its high-density population, needs to identify strategic areas that may be used to bring government service closer to the people;

WHEREAS, the Sanggunian shall use this information as reference for any future legislations which will require the establishment of facilities or any physical infrastructure;

WHEREAS, the availability or the lack thereof of real estate properties of the municipal government shall also serve as the basis of the Sanggunian to recommend other means to acquire property as may be deemed necessary;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby REQUESTS THE MUNICIPAL ASSESSOR'S OFFICE TO FURNISH THE SANGGUNIANG BAYAN AN INVENTORY OF ALL THE REMAINING UNUSED REAL ESTATE PROPERTIES INCLUDING THOSE WITH PENDING ISSUES AND DISPUTES, OF THE MUNICIPALITY OF TAYTAY FOR LEGISLATIVE PURPOSES.

RESOLVED FURTHER, that a copy of this Resolution be furnished to all Offices concerned for their information and appropriate action.


