WHEREAS, the DOH issued Administrative Order No. 2016 – 0038 entitled: “The Philippine Health Agenda 2016 – 2022” which seeks to fulfill the global call for universal health coverage, adopting “All for Health towards Health for All” as the rallying point to realize the vision of a healthy Philippines 2022;

WHEREAS, the appropriation is provided in the General Appropriations Act of 2022 or Republic Act 11639 for the DOH, under the Health Facilities Enhancement Program (HFEP) which shall be used for the construction, upgrading, expansion, repair and rehabilitation of LGU Health Care Facilities including the purchase of equipment in alignment with Ambisyon Natin 2040 and the Philippine Development Plan 2017 - 2022;

WHEREAS, DOH thru the HFEP CY 2022 has appropriated the amount of Two Million Nine Hundred Seventy Thousand Pesos only (Php 2,970,000.00) intended for the new construction of the Rural Health Unit to be implemented and procured by the LGU of Taytay, Rizal thru Transfer of Fund;

WHEREAS, assistance from the DOH for the improvement of Health Care Facilities and Services would be greatly beneficial to the constituents of this municipality;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE HON. MAYOR ALLAN MARTINE S. DE LEON TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH (DOH) – CENTER FOR HEALTH DEVELOPMENT CALABARZON FOR A FUND TRANSFER TO THE LOCAL GOVERNMENT UNIT (LGU)

OF TAYTAY, RIZAL UNDER THE TRUST FUND AGREEMENT TO BE UTILIZED FOR REPAIR AND REHABILITATION OF LGU HEALTH CARE FACILITIES.
