WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Taytay as a Legislative body of the Municipality is empowered to review the supplemental appropriation of barangays in the manner prescribed by law;

WHEREAS, Supplemental Budget No. 1 involving the amount of One Million Three Hundred Thousand Pesos (₱ 1,300,000.00) of Sangguniang Kabataan of Barangay Dolores was submitted to the Sangguniang Bayan for purposes of review;

WHEREAS, the source of funds for this supplemental budget of Sangguniang Kabataan of Barangay Dolores is from General Fund, Transportation Equipment amounting One Million Three Hundred Thousand Pesos (₱ 1,300,000.00);

WHEREAS, the Committee on Finance, Budget and Appropriation after reviewing Supplemental Budget No. 1 of Sangguniang Kabataan of Barangay Dolores recommend that it be declared Operative subject to the conditions stated in its report;

WHEREAS, Supplemental Budget No. 1 of Sangguniang Kabataan of Barangay Dolores is in conformity with existing budgetary rules and regulations in accordance with the provisions of the Local Government Code of 1991 and there is no impediment for the immediate approval thereof;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to APPROVE IN REVIEW AND DECLARE OPERATIVE THE SUPPLEMENTAL BUDGET NO. 1 OF THE SANGGUNIANG KABATAAN OF BARANGAY DOLORES TAYTAY, RIZAL, APPROPRIATING THE AMOUNT OF ONE MILLION THREE HUNDRED THOUSAND PESOS (₱ 1,300,000.00).

RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.


