A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ALLAN MARTINE S. DE LEON, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH EGC ENTERPRISES, REPRESENTED BY MR. MARK JOHN C. CANAVERAL, MANAGING HEAD, REGARDING THE TRANSPORT AND TREATMENT OF USED OIL FROM ESTABLISHMENTS BASED IN THE MUNICIPALITY WHICH ARE GENERATING HAZARDOUS INDUSTRIAL WASTES

WHEREAS, Section 16 of the Republic Act 7160 states that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the local government of Taytay is committed to ensure the proper segregation, collection, transport, storage, treatment and disposal of waste and identify programs to promote the proper handling, re-use and long-term disposal of waste;

WHEREAS, Section 10 of Republic Act 9003 or the Ecological Solid Waste Management Act of 2000 states that the collection of special waste shall be the responsibility of the municipality;

WHEREAS, industrial and commercial establishments, and some private houses, in their normal course of operation generate used oil and the Municipal Government of Taytay would want to properly transport and treat used oil whether for disposal, recycling or recovery;

WHEREAS, EGC Enterprises, a sole proprietorship existing under the laws of the Philippines, with plant address at Block 3 Lot 1 and 2, Victoneta Baytown, Barangay Kalayaan, Angono, Rizal, expressed its intent to partner with the Local Government Unit of Taytay and offered to transport and treat used oil from establishments based in the municipality;

WHEREAS, EGC Enterprises is a qualified and duly accredited hazardous Industrial Waste Transporter and Treater with Transporter Registration Certificate No. OL-TP-R4A-58-001220 and TSD Registration Certificate No. OL-TR-R4A-58-000085;

WHEREAS, this August Body needs to authorize the Local Chief Executive to enter and represent Taytay in a Memorandum of Agreement (MOA) with EGC Enterprises for the collection, safe handling and treatment of used oil generated by industrial establishments and households;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE LOCAL CHIEF EXECUTIVE, HON. ALLAN MARTINE S. DE LEON, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH EGC ENTERPRISES, REPRESENTED BY MR. MARK JOHN C. CANAVERAL, MANAGING HEAD, REGARDING THE TRANSPORT AND TREATMENT OF USED OIL FROM ESTABLISHMENTS BASED IN THE MUNICIPALITY WHICH ARE GENERATING HAZARDOUS INDUSTRIAL WASTES.

RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
