WHEREAS, the Department of Public Works and Highways has an ongoing installation of sheet piles along the end of the Bangiad river which drains to the Laguna Lake;

WHEREAS, the area, on which the river ends, is where local fisherfolks and farmers dock their boats, which will be blocked by the ongoing sheet piling;

WHEREAS, there are around 120 fisherfolks and kangkong farmers in the area, owning around 100 boats, whose entry to the lake will be affected by the sheet piling project;

WHEREAS, a construction of a boat dock may be added to the existing plan of the Department of Public Works and Highways to benefit the municipality's fisherfolks and farmers;

WHEREAS, a formal request submitted by Mr. Carlos V. Cantaco, President of Samahang Magsasaka sa Baybayin ng Lawa ng Laguna, highlights how this dock can revive and bring back the flow of "Gata Creek" perpendicular to Bangiad River;


WHEREAS, this body believes that this particular project is beneficial to the promotion and protection of our agricultural industry, as it would also help ensure a more sustainable income generating opportunities for the people in the area;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to REQUEST THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS TO INCLUDE IN THEIR PLAN, THE CONSTRUCTION OF A BOAT DOCK AT THE AREA OF BANGIAD, BRGY. SAN JUAN, TAYTAY, RIZAL, FOR THE BENEFIT OF FISHERFOLKS AND KANGKONG FARMERS.
