RESOLUTION NO. 97 series of 2022

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ALLAN MARTINE SINGCUENCO DE LEON, TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, REPRESENTED BY ITS REGIONAL DIRECTOR, BARRY R. CHUA, AND RATIFYING THE SAME, FOR THE IMPLEMENTATION OF SOCIAL PENSION PROGRAM FOR INDIGENT SENIOR CITIZENS IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL AND FOR OTHER PURPOSES

WHEREAS, Section 4, Article XV of the 1987 Constitution states that it is the duty of the family to take care of its elderly members while the State may design programs of social security for them;

WHEREAS, Section 17(iv) of Republic Act ("R.A.") No. 7160, otherwise known the Local Government Code, mandates that every local government unit shall implement "[s]ocial welfare services which include programs and projects on child and youth welfare, family and community welfare, women's welfare, welfare of the elderly and disabled persons";

WHEREAS, Social Pension for Indigent Senior Citizens (SocPen) is a government assistance mandated under R.A. No. 9994 or otherwise known as Expanded Senior Citizens Act of 2010;

WHEREAS, the Municipal Government of Taytay is in-charge to facilitate the payout of Social Pension for Indigent Senior Citizen covering the 3rd and 4th quarter of year 2022 targeting 3,636 beneficiaries;

WHEREAS, the Municipal Government of Taytay is mandated to submit all necessary requirements upon receiving the allocated funds from the Department of Social Welfare and Development with the amount of Ten Million Nine Hundred Eight Thousand Pesos (Php 10,908,000.00);

WHEREAS, as stipulated in R.A. No. 11639, the Department of Social Welfare and Development shall ensure that the stipend shall be given directly to senior citizen beneficiaries and the most cost-effective and efficient modality of stipend distribution must be employed;

WHEREAS, a Memorandum of Agreement for the said purpose is needed between the Department of Social Welfare and Development and the Municipal Government of Taytay, Rizal;

WHEREAS, the Municipal Government of Taytay recognizes its role as mandated by the aforesaid laws, and commits to address the needs of the poor, especially the senior citizens;

WHEREAS, to ensure the expeditious delivery of Serbisyong May Ngiti to Senior Citizen Taytayenos, fund transfer to the Municipal Government of Taytay is identified as a mode of payment by the Department of Social Welfare and Development;

WHEREAS, under the R.A. NO. 7160, the Local Chief Executive is mandated to represent the Municipality in entering into contracts after being authorized for said purpose by the concerned Sangguniang Bayan;

WHEREAS, a Memorandum of Agreement (MOA) was executed by the Municipal Government of Taytay, represented by Mayor Allan Martine S. De Leon, and the Department of Social Welfare and Development, represented by its Regional Director Barry R. Chua for the implementation of the Social Pension Program;

WHEREAS, although the Local Chief Executive has the authority to enter into MOAs or Contracts regarding Programs, Projects and Activities by virtue of Resolution No. 25 series of 2022 of this Sangguniang Bayan, the parties under the MOA deemed it necessary to require that specific authorization for this purpose be given to the Local Chief Executive;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR ALLAN MARTINE SINGCUENCO DE LEON, TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, REPRESENTED BY ITS REGIONAL DIRECTOR, BARRY R. CHUA, AND RATIFY THE SAME, FOR THE IMPLEMENTATION OF SOCIAL PENSION PROGRAM FOR INDIGENT SENIOR CITIZENS IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL AND FOR OTHER PURPOSES.


RESOLVED FURTHER, that this authority is retroactive on the day that the MOA between the Local Government of Taytay and DSWD was signed.


