WHEREAS, Section 9 of Article II of the 1987 Constitution provides that: "The State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from the poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all";

WHEREAS, Section 20 of the same article provides that: "The State recognizes the indispensable role of the private sector, encourages private enterprise, and provides incentives to needed investments";

WHEREAS, RA 7160 likewise provides that the Local Chief Executive shall represent the municipality in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Bayan or pursuant to law or ordinance;

WHEREAS, the SNTD Express Corporation, developer of the SEND IT App, expressed its intent to partner with the Local Government Unit of Taytay, with the purpose of providing additional revenue to tricycle drivers and protect the safety of the public;

WHEREAS, in a series of public consultations, the TODA Federation of Taytay interposes no objection to the operation of SEND IT App within the municipality;

WHEREAS, this August body recognizes the importance of this partnership as this will pave the way for the improvement of existing transportation services in the municipality;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE HONORABLE MAYOR ALLAN MARTINE S. DE LEON TO REPRESENT THE MUNICIPAL GOVERNMENT OF TAYTAY TO SIGN THE MEMORANDUM OF AGREEMENT BETWEEN THE MUNICIPAL GOVERNMENT OF TAYTAY AND THE SNTD EXPRESS CORPORATION REPRESENTED BY ITS PRESIDENT EDUARD DELEGERO, AND FOR OTHER PURPOSES.

RESOLVED FURTHER, that the Memorandum of Agreement between the Taytay LGU and the SNTD Express Corporation shall be ratified by the Sangguniang Bayan prior to its implementation.


RESOLVED FURTHERMORE, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
