A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ALLAN MARTINE S. DE LEON, MPA, TO ENTER INTO MEMORANDUM OF AGREEMENT FOR THE MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE OF RIZAL, WITH THE DEPARTMENT OF HEALTH-TAGAYTAY TREATMENT AND REHABILITATION CENTER (“DOH-TTRC”) REPRESENTED BY ITS CHIEF OF HOSPITAL, DR. MA. TERESA C. IÑIGO, MD, FPCAM, CESE, FOR PROVIDING TREATMENT AND REHABILITATION TO TAYTAYEÑO DRUG PATIENTS

WHEREAS, Section 15, Article II of the 1987 Constitution mandates the State to “protect and promote the right to health of the people and instill health consciousness among them”;

WHEREAS, the DOH-TTRC is mandated under Republic Act (“R.A.”) No. 9165, otherwise known as the “Comprehensive Dangerous Drugs Act of 2002”, to treat and rehabilitate drug dependents in the country in order to re-integrate them into society;

WHEREAS, the vision of DOH-TTRC is to become a strong partner in the establishment of drug-free Philippines, particularly in the CALABARZON region and emphasize the importance of participation of Local Government Units (LGUs) in safeguarding the citizenry from the harmful effects of dangerous drugs through the establishment of Special Drug Education Centers (SDECs);

WHEREAS, in providing utmost *Serbisyong May Ngiti* to all Taytayeños, the Municipal Government, aims to strengthen social and health services available in the Municipality by providing treatment and rehabilitation center to Drug Dependent Taytayeños in furtherance to the vision of establishing a drug-free Taytay, Rizal;

WHEREAS, the Memorandum of Agreement (“MOA”) covers a unique circumstance of providing Treatment and Rehabilitation Center to the Municipal Government by DOH-TTRC based on the number of drug dependent patients in the Municipality;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayeños, the signing of the MOA will provide much needed social and health services to drug dependent Taytayeños;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR ALLAN MARTINE S. DE LEON, MPA, TO ENTER INTO MEMORANDUM OF AGREEMENT FOR THE MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE OF RIZAL, WITH THE DEPARTMENT OF HEALTH-TAGAYTAY TREATMENT AND REHABILITATION CENTER (“DOH-TTRC”) REPRESENTED BY ITS CHIEF OF HOSPITAL, DR. MA. TERESA C. IÑIGO, MD, FPCAM, CESE, FOR PROVIDING TREATMENT AND REHABILITATION TO TAYTAYEÑO DRUG PATIENTS.

RESOLVED FURTHER, that copies of the MOA to be entered into by the Municipal Mayor and DOH-TTRC be furnished to the Sangguniang Bayan for its information and ratification.


RESOLVED FURTHERMORE, that copies of this Resolution be forwarded to the Office of the Municipal Mayor, and all concerned offices in the Municipal Government of Taytay.
