WHEREAS, in the year 2003, National Day Care Workers' Week was proclaimed through Presidential Proclamation No. 404 series of 2003 which provides that local government daycare workers organized themselves into the National Federation of Day Care Workers of the Philippines Inc., for their personal development, career growth, personal advancement and perform frontline functions in helping mold young children during their early years of education;

WHEREAS, Day Care Workers were engaged in the provision of child development services and programs such as care, education, protection, and social development to ensure children learn basic skills and concepts, such as communication, good manners, and sharing at a very young age;

WHEREAS, Day Care Workers gave their untiring services to the young children and sacrificed their time and effort to ensure the quality of education of our young children and molded them to be a better person as they grow old;

WHEREAS, most of the Day Care Workers in this Municipality have been in the service for more than 20 years, and out of 45 Day Care Workers 23 are still under the Job Order Contract and 8 are Barangay Paid;

WHEREAS, the members of the Sangguniang Bayan are humbly requesting our Local Chief Executive, Hon. Allan Martine S. De Leon, MPA, to appoint our Day Care Workers to

regular or regular casual position in exchange for their sacrifices and untiring services for the sake of our young children;

RESOLVED FURTHER, that copies of this Resolution be furnished and forwarded to all concerned for their information and appropriate action.


