A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ALLAN MARTINE S. DE LEON, MPA, TO ENTER AND SIGN FOR THE MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE OF RIZAL THE MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF RIZAL REPRESENTED BY HON. GOVERNOR NINA RICCI A. YNARES, FOR THE GRANT OF USUFRUCTUARY RIGHTS

WHEREAS, Section 15, Article II of the 1987 Constitution mandates the State to *“protect and promote the right to health and instill health consciousness among them”*;

WHEREAS, Section 16 of Republic Act (“R.A.”) No. 7160, otherwise known as the Local Government Code of 1991, provides that Local Government Units should *“exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*;

WHEREAS, Section 444(b)(1)(vi) of R.A. No. 7160, provides that the Municipal Mayor *“[u]pon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance”*;

WHEREAS, the Municipal Government of Taytay is the declared owner of a parcel of land covered by Tax Declaration 18-TY-002-08242, Cadastral Lot No. 6333, consisting of One Thousand Nine Hundred Seventy-Eight Square Meters (1,978 sqm.) located at Rizal Avenue, Barangay Dolores, Municipality of Taytay;

WHEREAS, the 11th Sangguniang Bayan of Taytay adopted Resolution No. 15, Series of 2019 requesting the Hon. Rebecca A. Ynares, former Provincial Governor of Rizal, to construct and manage a Provincial General Hospital within the jurisdiction of the Municipality of Taytay for the benefit of its constituents and nearby Municipalities;

WHEREAS, the Provincial Government of Rizal adopted Resolution No. 421, Series of 2019 approving the establishment of the Rizal Provincial Hospital System (“RPHS”) in the Municipality of Taytay;

WHEREAS, the Memorandum of Agreement (“MOA”) for the grant of usufructuary rights between the Municipal Government and the Province of Rizal will formalize the establishment of RPHS in the Municipality of Taytay;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti*, the signing of the MOA will provide much needed health services for the welfare and development of Taytayefios;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR ALLAN MARTINE S. DE LEON, MPA, TO ENTER AND SIGN FOR THE MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE OF RIZAL THE MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF RIZAL REPRESENTED BY HON. GOVERNOR NINA RICCI A. YNARES, FOR THE GRANT OF USUFRUCTUARY RIGHTS.

RESOLVED FURTHER, that copies of the MOA entered into by the Municipal Mayor and the Provincial Government of Rizal be furnished to the Sangguniang Bayan for records purposes and for information purposes.

RESOLVED FURTHERMORE, that copies of this Resolution shall be forwarded to the Office of the Municipal Mayor, and all concerned offices in the Municipal Government of Taytay.
