RESOLUTION NO. 231 series of 2023

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR ALLAN MARTINE S. DE LEON, MPA, TO SIGN THE NON-DISCLOSURE AND CONFIDENTIALITY AGREEMENT WITH THE DEPARTMENT OF TRANSPORTATION REPRESENTED BY USEC. CESAR B. CHAVEZ, UNDERSECRETARY FOR RAILWAYS, FOR THEIR NATIONAL GOVERNMENT INFRASTRUCTURE PROJECTS

WHEREAS, Section 444(b)(1)(vi) of Republic Act (“R.A.”) No. 7160, otherwise known as the Local Government Code provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, Section 444(2), Article I of R.A. No. 7160 provides that the Municipal Mayor shall enforce all laws and ordinances relative to the governance of the municipality and the exercise of its corporate powers, and implement all approved policies, programs, projects, services and activities of the municipality;

WHEREAS, the Local Government Unit requires the Department of Transportation (“DOTr”) to sign a Non-Disclosure and Confidentiality Agreement (“NDA”) prior to the implementation of the National Government Infrastructure Projects;

WHEREAS, the Municipal Government of Taytay will be included in the deliberations once the projects are ready for public consultation;

WHEREAS, the Municipal Mayor is authorized to enter into and sign a Memorandum of Agreement (“MOA”) and/or Memorandum of Understanding (“MOU”) in behalf of the Municipality of Taytay, Rizal for the implementation of Projects, Programs and Activities (“PPAs”) from various National Government Departments, Offices, Agencies, Political Subdivisions and Government Funding Entities to the Municipality by virtue of Sangguniang Bayan Resolution No. 25, Series of 2022, while this Resolution is specific only for the signing of the NDA;

WHEREAS, the NDA once signed by the Municipal Mayor will be subject to ratification by the Sangguniang Bayan in accordance with Section 444 (b)(1)(vi) of R.A. No. 7160;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayeños and the implementation of various national government infrastructure projects in the Municipality of Taytay, the signing of said NDA with the DOTr for their national government infrastructure projects is hereby necessary;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR ALLAN MARTINE S. DE LEON, MPA, TO SIGN THE NON-DISCLOSURE AND CONFIDENTIALITY AGREEMENT WITH THE DEPARTMENT OF TRANSPORTATION REPRESENTED BY USEC. CESAR B. CHAVEZ, UNDERSECRETARY FOR RAILWAYS, FOR THEIR NATIONAL GOVERNMENT INFRASTRUCTURE PROJECTS.

RESOLVED FINALLY, that a copy of this Resolution shall be forwarded to the Office of the Municipal Mayor, and all concerned offices in the Municipal Government of Taytay.


