A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO NEGOTIATE, SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH SAINT LOUIS UNIVERSITY, SPECIFICALLY SUNFLOWER CHILDREN'S CENTER REPRESENTED BY FATHER GERALDO COSTA, TO CONDUCT MEDICAL AND SOCIAL PROGRAM IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL, AND FOR OTHER PURPOSES

WHEREAS, Section 3 (2) Article XXV of the 1987 Constitution, provides that “[t]he State shall defend the right of children to assistance, including proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty, exploitation, and other conditions prejudicial to their development”;

WHEREAS, Section 2 of Republic Act No. 11036, otherwise known as the “Mental Health Act” declares that “[t]he state affirms the basic right of all Filipinos to mental health as well as the fundamental rights of people who require mental health services”;

WHEREAS, Section 444(b)(1)(vi) Article 1, Chapter III, Title II of Republic Act (“R.A.”) No. 7160, otherwise known as the Local Government Code provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, through the Municipal Social Welfare and Development Office, the Saint Louis University - Sunflower Children's Center communicated its intent to conduct several medical and social programs of voluntary nature within the Municipality of Taytay, Province of Rizal;

WHEREAS, the Convention on the Rights of the Child (“CRC”) asserts that State Parties shall take all appropriate legislative, administrative, social and educational measures to protect the child from all forms of physical or mental violence, injury or abuse, neglect or negligent treatment, maltreatment or exploitation, including sexual abuse;

WHEREAS, such protective measures should, as appropriate, include effective procedures for the establishment of social programs to provide necessary support for and follow up instances of child maltreatment;

WHEREAS, the Municipal Government of Taytay, Rizal wishes to avail of the services of the Saint Louis University specifically Sunflower Children's Center;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO NEGOTIATE, SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH SAINT LOUIS UNIVERSITY, SPECIFICALLY SUNFLOWER CHILDREN'S CENTER REPRESENTED BY FATHER GERALDO COSTA, TO CONDUCT MEDICAL AND SOCIAL PROGRAM IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL, AND FOR OTHER PURPOSES.

RESOLVED FURTHER, that the signed Memorandum of Agreement shall be ratified first by the Sangguniang Bayan before its full implementation.


