**RESOLUTION NO. 258 series of 2023**

**A RESOLUTION APPROVING IN REVIEW DECLARING THE SUPPLEMENTAL BUDGET NO. 1 S. 2023 OF BARANGAY SAN JUAN IN THE AMOUNT OF NINETEEN MILLION TWO HUNDRED FIFTY THOUSAND PESOS (PHP 19,250,000.00) UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 1 S. 2023 OPERATIVE IN PART**

WHEREAS, the Supplemental Budget No. 1 s. 2023 of Barangay San Juan was submitted to the Sangguniang Bayan for purposes of review pursuant to the provision of R.A. 7160 otherwise known as the Local Government Code of 1991;

WHEREAS, the Supplemental Budget No. 1 s. 2023 of Barangay San Juan as submitted was initially reviewed and evaluated and have made the following recommendations:

1. **Section 8.0** of DBM Budget Circular 2022-4 states that:  
“The grant of the one-time SRI to employees in LGUs, including those in the barangays, shall be determined by their respective sanggunian depending on the LGU’s financial capability, at a uniform rate not exceeding Twenty Thousand Pesos (P 20,000) each, subject to the following conditions:  
**Section 8.3** In determining the amount of the SRI, the sanggunian shall exercise prudence and judicious use of government funds, ensuring that the expenditure is reasonable and will not, in any way, adversely affect the delivery of services to the public.  
“Since the funding source is the FY 2022 local budget, the corresponding supplemental budget for the purpose shall be enacted by the local Sanggunian within FY 2022.”

The requirement stated above had not been met by Barangay San Juan for their supplemental budget was enacted on June 16, 2023, thus, the release of Ten Million (P 10,000,000.00) on SRI item shall be disallowed based on DBM Budget Circular 2022-4.

WHEREAS, Barangay San Juan submitted the Barangay Supplemental Budget Preparation (BSBP) Form No. 6 Statement of Supplemental Appropriations that indicates corresponding AIP code of each supplemental line item;

WHEREAS, the General Fund amounting to Six Million Fifty Thousand Pesos (P 6, 050,000.00) may be declared operative provided that Barangay San Juan address the findings of the disallowed item, particularly item no. 1 of the review and evaluation of the Local Finance Committee (hereto attached);

WHEREAS, the 20% Development Fund amounting to Three Million Two Hundred Thousand Pesos (P 3,200,000.00) may be declared operative considering that the same was included in their AIP;

WHEREAS, it is the best interest of the Sangguniang Bayan that Barangay San Juan address the findings immediately so as not to hamper the services of the Barangay;

WHEREAS, the Committee on Finance, Budget and Appropriation after reviewing Supplemental Budget No. 1 s. 2023 of Barangay San Juan recommends that it be declared operative in part;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to APPROVE IN REVIEW DECLARING THE SUPPLEMENTAL BUDGET NO. 1 S. 2023 OF BARANGAY SAN JUAN IN THE AMOUNT OF NINETEEN MILLION TWO HUNDRED FIFTY THOUSAND PESOS (PHP 19,250,000.00) UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 1 S. 2023 OPERATIVE IN PART.

RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.


